1.2 Important Notice

1. To preserve intellectual property rights, all exhibitors are forbidden to exhibit counterfeit. Any cost due to the act of infringement is on the account of the infringers.
2. All the exhibits must be relative to the given theme.
3. All booths are not allowed to underlet by any means.
4. Booth décor may not affect the joint area. All the décor may not exceed the defined boundary. The partition that facing the adjacent is not allowed to cover with slogan, pattern or pictures, yet leaves it with bare décor material. It must be covered with white paint or whiteboard otherwise the exhibitor will be fined from the deposit depending on the case.
5. All drawings must be submitted to the contractor. Hanging point is not allowed. Posters and storage items may not exceed the booth area. Exhibitors are not allowed to hand out leaflets in the public area.
6. Raw Space: booth area 9-199sqm, height limit 4.4m; booth area \geq 200sqm, height limit 6m.
7. Any sound must not exceed 65 dB (A) at the booth boundary. Loudspeakers must face to the booth. If any exhibitor breaches this article, the organizer has rights to cut down its electricity or take other actions



after ineffective dissuasion.

8. To maintain the fine image of the exhibitor and be responsible for professional visitors, all exhibitors are not allowed to move out before 14:00, Nov. 23rd, 2019.
9. Organizer is not responsible for any service provided by the third party.
10. Food outside the venue is not allowed to be taken inside. Food can be purchased from certificated catering units inside the venue.
11. In accordance with the national and Shanghai food safety laws and regulations, the pavilion will strictly manage the catering services, and no other foreign boxed meals will be allowed to enter the pavilion except the catering units permitted by the pavilion

1.4 Traffic Guide

National Exhibition and Convention Center (Shanghai) ----NECC (Shanghai)

1.4.1 Starting from Airports: National Exhibition and Convention Center (Shanghai) is only 2km away from the Shanghai Hongqiao International Airport and 60km away from the Shanghai Pudong International Airport. Passengers will take Subway Line 2, get off at East Xujing Station or go by taxi.

1.4.2 Starting from Railway Stations: NECC (Shanghai) is only 1.5km away from the Hongqiao Railway Station and it can be arrived by the Subway Line 2. NECC (Shanghai) also is 25km away from Shanghai Railway Station and 23km away from Shanghai South Railway Station. Passengers will take Line 1 to the People's Square then transfer Line 2, get off at East Xujing Station.

1.4.3 Going by Subway: Take Subway Line 3 or Line 4 and then transfer to Line 2 at Zhongshan Park Station, Passengers will get off at East Xujing Station. Shanghai Subway Map (see as Fig.1 below) can be found at all subway stations).

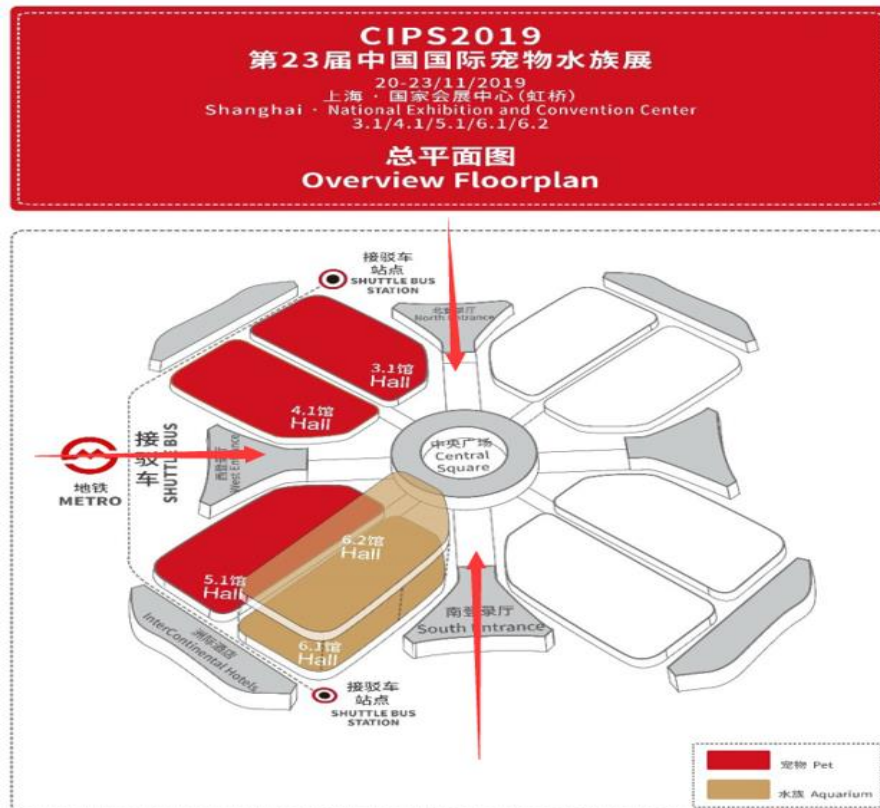

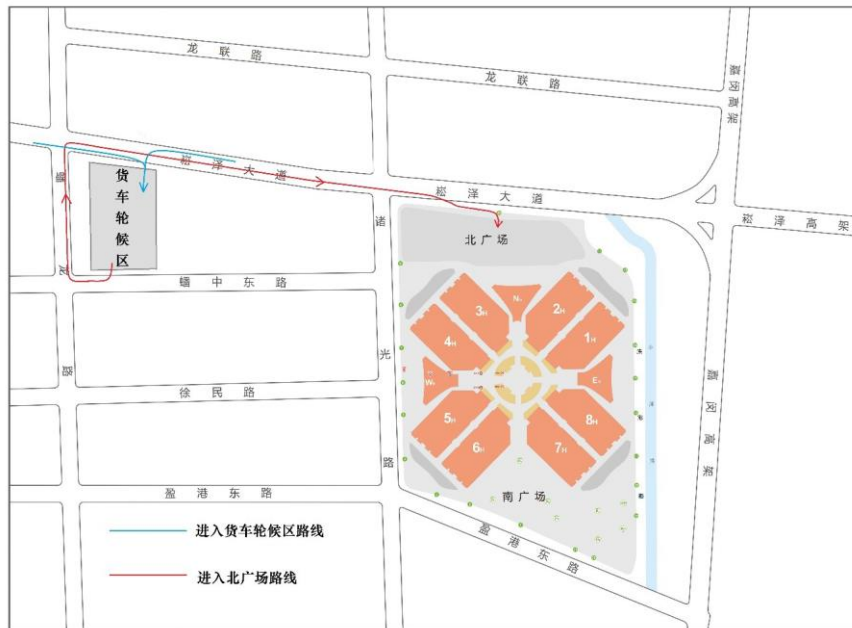

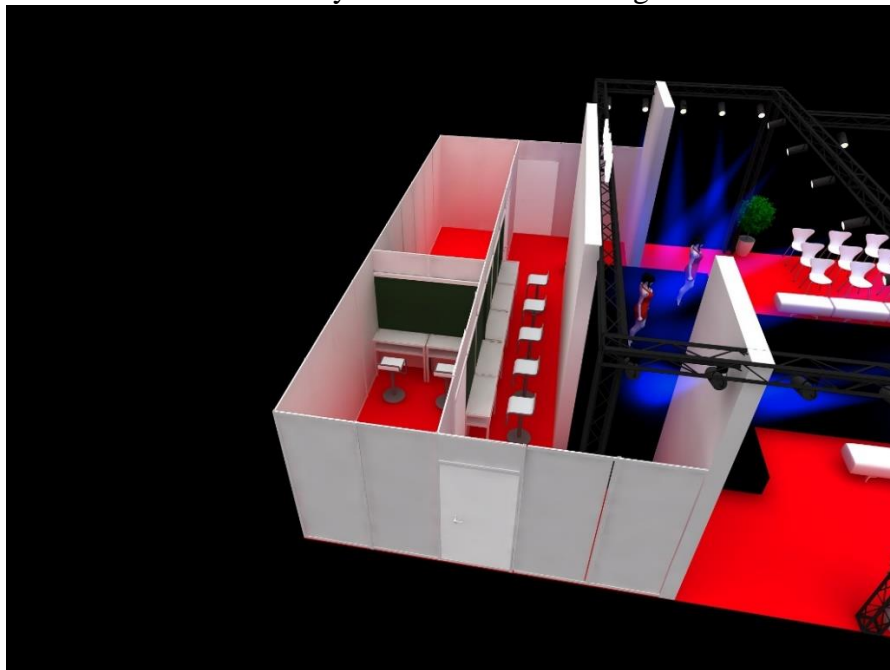

3.1 Raw Space

3.1.1 Construction Approval Process and Price

1. The blueprint auditor will check if the documents are enough or intact and verify the design blueprint. After his verification, he will fill in his suggestion and propose changes. After the applicant of the constructor has taken the advice from the auditor, the applicant should signs for the advice. Application with incomplete documents or incorrect blueprint should apply again.
2. Blueprints and documents which have passed verification will be registered and filed by the auditor. After that, the auditor will send the application form of construction to the service list keyboarder.
3. The keyboarder will verify the service items and quantities that the constructors apply for. After the verification, the keyboarder will make a list of charges.
4. Constructor pays for the related bills and deposit of the booth with the list. The fee and the deposit have to be paid in one-time. We will not accept your application for construction if you only paid the fees or the deposit. Exhibitors have to pay in cash after Oct. 11 2019, we will not accept payment through check or remittance after that day.
5. After the payment, constructors should send the receipt with financial seal to the service list keyboarder and get the construction car pass, constructor badges. The application for construction is over then.
6. If constructor wants to add service during building-up, they have to go to the service counter official stand fitting contractor in the service center and fill an application form. The staff there will accept or refuse the application according to the condition of the venue. If the staff accepts the application, the staff will charge for it and arrange the service.

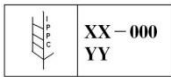

Special arrangements have been made with the China Customs and Health Authorities to facilitate clearance and quarantine formalities, thus avoiding many of the complex procedures usually associated with animal nature and pet food items imports. Please use the enclosed List of Exhibits form and include values in your paperwork. All shipments are to be covered by the copy Certification of Origin and Official Government Health Certificates which are to be sent together with List of Exhibits to us not later than 30 working days of the official freight deadline to process import permits. Exhibitors are advised **NOT** to send shipment to China directly without our confirmation in advance. All these kind of items will incur duties and tax and they are non-refundable. The handling and service charges for these kinds of item, quotation will be furnished upon request. Application of Animal Nature Quarantine / Isolate Certificate (if required) it takes at least 14 working days. The cost of Hygiene Certificate / Isolate charges will be billed according to actual expenses.

9b. **CUSTOMS INSPECTION**

The China customs are strict and through in their inspection of goods. All packages can be expected to be opened and contents checked against the List of Exhibits (Form B). Exhibitors must provide us with the brand name, model number, serial number of machine and quantity of equipment / parts in the List of Exhibits form. Please ensure that the brand name, model number or serial number can be found on the machine and equipment itself to facilitate customs inspection. In order to obtain early release of goods from customs, machine catalogues or photo of equipment / parts must be attached with List of Exhibits.

10b. **CATALOGUES AND PUBLICITY MATERIALS - CENSORING**

Brochures and souvenirs items are permitted entry into China giveaways e.g. souvenir (i.e. pens, key chains, note pads etc.) with reasonable quantities and low value may be duty-exempted. It is, however, subject to China customs approval. Therefore, all exhibitors should prepare an envelope containing 2 samples of each giveaway items for censoring. 11b. **PACKING**

Please ensure your equipment is packed in a strong, waterproof packing case which lends itself to being re-packed after the exhibition. Please bear in mind that your exhibits will be in transit for long periods both to and from the exhibition and that cartons are not suitable to withstand the constant handling which takes place during transshipment. Shocking and bumping will sometimes be inevitable and cases may be placed in open air storage without cover, therefore exhibitors must take the necessary precautions against damage and rain.



12b. UNPACKING OR REPACKING ON –SITE
